## AAFCO – FDA meeting

#### The FSMA Rules:

- Preventive Controls Human Food and Animal Feed
- Produce Rules
  - "mixed facility" definition implications for on-farm presence
  - Side discussions among NASDA leadership about state internal structures to address issues raised by the produce rule. Particularly regarding on-farm presence by agencies that have been traditionally non ag
- Foreign Supplier Verification Programs
  - Added public meetings
- Accreditation of Third-Party Auditors/Certification Bodies
  - Added public meetings

#### **FSMA Rules**

- Broadly stated purpose: To attain greater consistency and expected consistencies in state and federal animal feed programs, which differ from human food programs.
- Sequestration funding may limit program implementation.
- Without FDA funds, some states may still proceed to the extent existing resources permit.
- Pertains to improved performance in state programs, not in regulated facilities.
- Very similar to Manufactured Food Regulatory Program Standards, but human food/animal feed need to be differentiated.

Animal Feed Regulatory Program Standards (AFRPS)

## FDA GRANT: Building an Integrated Laboratory System to Advance the Safety of Food and Animal Feed

- FDA 5-year grant to APHL, AFDO, and AAFCO
- \$1.5 million Yr 1 reduced to \$750K Yr 2, due to sequestration. AAFCO share ca. \$187,500. Future funding not defined.
- Nancy Thiex (SD Emeritus), is AAFCO Program Manager for the grant.
- Implications: Immediate restrictions are not debilitating. The progress made in the feed goals may be slowed significantly, if funding is not restored. Raises discussion about feed and food priorities in the IFSS.



Food Safety Preventive Controls Alliance (FSPCA)

- Illinois Institute of Technology –
   FDA grant recipient
- Similar to other Alliance's formed to implement FDA FSMA Rules and strategies.

Partnership for Food Protection (PFP)

- All FSMA rules will require training for both regulators and the regulated.
- FDA will have a strong presence in the training and in the field – how it will implement FSMA charges and trainings is yet to be clarified.
- Integrated Food Safety System anticipates that all parties, i.e., federal, state, locals, will have inter related, defined roles to play. These roles will require training and cross training at all levels to bring an effective IFSS.

Trainings, Trainings, and Trainings

- Preventive Controls Alliance, IFPTI, FDA, Cooperative Extension Service, and many others expected, will be training providers of an approved curriculum.
- Preventive Controls for Human Food Curriculum and related processes will serve as template for Animal Feed preventive Controls.
- How these several trainings will be coordinated and funded in support of an IFSS is an active discussion.

## AAFCO Online Official Publication

- Which version is "Official"?
   AAFCO builds model regulations that states or nations can adopt to regulate feed.
- The OP is planned to be updated after each membership vote.
- The regulations the government entity adopts are the rules firms must follow. Many firms and states already recognize ingredient definitions long before they reach official status. Firms are encouraged to work closely with those enforcing the state law to determine what is allowed in your marketplace.

#### AAFCO Online Official Publication (2)

- AAFCO is busy with many new issues both external and internal.
- AAFCO is attempting to address internal supports by training upcoming leaders.
- AAFCO is engaging those outside the organization through various means, PFP, grants, AAFCO meetings, comments on FSMA rules, trainings, etc.
- Training will be a much larger issue in the very near future.
- FSMA Rules and their implications are continuing issues for AAFCO and member states.
- AFRPS will be increasingly important for demonstration of feed program attainment to accepted standards.
