


#### Annual U.S. Ethanol Capacity and Mandated Levels (gallons in billions)












Corn Used for Ethanol as a Percentage of U.S. Corn Production

- Erosion of Profitability
- Lender's Unwillingness/Inability to Increase Credit Facility to Meet Margin Calls
- Owner's Inability to Make Equity Contributions
- Potential Loss of Grain Dealer License
