# A letter from the president and CEO: In full swing this spring

Hello from Washington where flowers are blooming, the temperatures are beginning to rise and peak tourist season is rapidly approaching. I know that April is often the start of a busier time of year for many of you and your employees, and it means that we are just weeks away from the start of wheat harvest for some of our members. Maybe it's because our oldest child is a senior this year, and we're managing all the activities and important choices that come with it, but it feels like the first quarter of the year has passed by in the blink of an eye. It was also a very busy and productive quarter for NGFA on behalf of our members.

The Executive Committee met in January and twice at the convention in Orlando in mid-March, along with the Board of Directors meeting. NGFA's budget was approved for our new fiscal year which runs from April 1 to March 31. The meetings also included updates on the continued implementation of the long-range plan approved in March 2022, implementation of the Committee Task Force recommendations approved by the Board last September (more on this topic below), and efforts to expand and improve communications to NGFA members. New Board members were seated for the first time and appointments were made to the Executive Committee, including new members Jeff Bechard, Paul Katovich and Kellie Melton. I want to especially thank Gary Beachner and Jean Bratton, whose terms on both the Board and EC ended in March, for their many years of service to NGFA in these leadership positions as well as other committees and task forces.

NGFA's 128<sup>th</sup> annual convention was highly successful, with more than 650 attendees enjoying the beautiful Orlando weather for numerous networking opportunities, meetings of NGFA committees and outstanding general session speakers.

Notably, this year's convention served as the backdrop for the full implementation of the new committee structure approved by the Board. In 2023, NGFA conducted the first major review and restructuring of the committees in many years. All new, continuing and restructured committees met during the convention with great discussion and feedback. Our committees and the more than 300 volunteers serving on them guide NGFA's priorities in all areas. Members consistently tell us that our committees are the "backbone" of NGFA and are viewed as one of the most important aspects of membership in the association.

Convention is always NGFA's premier event of the year, and I thank each of you who attended. I also thank our staff team that put in hundreds of hours to make it a success for our members. We invite you to join us next year in Carlsbad, Calif., on March 9-11 for NGFA's 129<sup>th</sup> annual convention.

In addition to convention, members of the NGFA staff team spoke at numerous meetings around the country in January, February, and March. We also continued hosting regional safety seminars, which members say are one of the most valuable benefits NGFA offers.

In the second quarter, we are planning for the Trade Rules Seminar in St. Louis, Mo., in early May, along with a Capitol Hill fly-in and advocacy campaign in June that will include meetings of the Executive Committee, several NGFA committees and our Committee Apprentice Program (CAP) participants.

## NASS discontinues county-level production data

The U.S. Department of Agriculture (USDA) National Agricultural Statistics Service (NASS) announced on April 9 that it is discontinuing several programs and reports including county estimates for crops and livestock.

NASS said it is discontinuing all county estimates for crops and livestock beginning with the 2024 production year as well as canceling the July cattle report and discontinuing the cotton objective yield survey.

"The decision to discontinue these surveys and reports was not made lightly, but was necessary, given appropriated budget levels," NASS stated in its notice.

### NGFA supports tax relief bill

NGFA joined 33 other agriculture groups to urge Senate leaders to take up the Tax Relief for American Families and Workers Act, which includes provisions for business expenses and bonus depreciation.

"Producers and businesses throughout the food and agriculture industry are facing tax increases today and cannot wait a year or more for relief," the groups noted in an <u>April 8 letter</u> to Senate Majority Leader Chuck Schumer, D-N.Y., and Minority Leader Mitch McConnell, R-Ky.

H.R. 7024, the Tax Relief for American Families and Workers Act passed the House of Representatives with broad bipartisan support and is awaiting action in the Senate.

Farmers, ranchers and agricultural businesses are facing a series of tax increases as provisions in the Tax Cuts and Jobs Act (TCJA) have either already expired or are set to expire at the end of 2025, the groups noted.

"In the interim, we must immediately restore the already expired and slimmed-down business provisions to help these families and to stimulate economic growth," the groups stated.

### Biden administration finalizes two-person rail crew rule

The Transportation Department's Federal Railroad Administration (FRA) <u>finalized a rule</u> earlier this month to require major freight railroads to maintain two-person rail crews.

A top priority for rail labor unions, the rule codifies train crew staffing rules at a federal level. In limited cases, the rule permits exceptions for smaller railroads to continue or initiate one-person train crew operations by notifying FRA.

In comments submitted to the agency, rail carriers argued the rule would stifle technological efficiencies and put them at a disadvantage to trucking which is becoming more automated.

Representatives for railroads said the size of train crews should be determined by contract talks and argued that there is not enough safety data to justify a federal rule. Association of American Railroads CEO Ian Jefferies said: "Instead of prioritizing data-backed solutions...FRA is looking to the past and upending the collective bargaining process."

Labor agreements requiring two-person crews have been in place for decades at most major railroads, while many short-line railroads operate with one-person crews.

At least 11 states have already approved rules requiring two-person crews. According to FRA, the rule will prevent "a patchwork of potentially inconsistent rules governing train operations across the country."

FRA first proposed a two-person crew mandate in 2016, but it was later abandoned during the Trump administration after the agency concluded it did not have enough evidence to support it. Meanwhile, a rail safety bill introduced in Congress last year included a requirement for two-person crews, but the legislation failed to gain enough legislative support.
